Plan Description

Deferred Interest with Payments: the customer is required to pay a minimum monthly payment during the promotional period. Interest accrues at the standard account APR during the promotional period. Accrued interest is charged to the customer's account if the original purchase amount is not paid in full by the end of the promotional period. (Plan #1)

Fixed # Payments with low APR: the customer is required to make equal payments based on the purchase amount plus interest assessed on the outstanding balance in each billing cycle during the promotional period. (Plan #2)

Deferred Interest with an Equal # Payments: the customer is required to make equal payments of the purchase amount for the promotional period. Interest accrues at the standard account APR during the promotional period. Accrued interest is charged to the customer's account if the original purchase amount is not paid in full by the end of the promotional period. (Plan #3)
